  - f. To ascertain the exact number of doping tests held by AFP in last three years.
  - g. To fix responsibility upon the person(s) involved, if any except athletes (banned by the Anti Doping Organization of 13<sup>th</sup> South Asian Games).
  - h. To recommend measures for future course.
  - i. To ascertain necessary information / data related to measures of doping control in last five years by Anti Doping Organization of Pakistan and other actions taken to mitigate the risk of doping control violation(s) in Pakistan.
