Following our meeting on 4 October 2013 in Lausanne and the IOC Director General's letter of 11 October 2013 (attached for reference), we are pleased to send you (attached) the complete list of all confirmations received from the International Federations of the status and representatives of their respective national federations in Pakistan.

This list results from an in-depth investigation conducted with the IFs and must serve as a basis to establish/confirm the legitimate composition of the POA.

As agreed upon during our meeting in Lausanne and as mentioned in the IOC letter of 11 October 2013, this list must definitively clarify any doubt as to the membership of the national federations to the POA and must be accepted by all parties. Within this framework, the POA must now be able to operate as normal (including access to the POA office and bank account) and any decision made by the POA within this framework will have to be fully respected by all parties and will no longer be challenged from outside.

With this work, the IOC has now completed its part of the roadmap.

In parallel to this, it was also agreed that the Government of Pakistan would review urgently the few conflictive issues of the Sports Policy (clearly identified by the IOC since 2012 and communicated to all of you) to make it fully compatible with the basic principles and rules which govern the Olympic Movement.

Consequently, we should be grateful if the Government of Pakistan could update us on the progress made with the revision of the Sports Policy and inform us of the deadlines to complete this process.

We hope this will help resolve all pending issues in a constructive manner and in accordance with the commitments taken by each party on 4 October 2013 as summarized in the IOC letter of 11 October 2013.

Thank you for your cooperation and we look forward to hearing from you at your earliest convenience.
