#### INSTRUCTIONS TO CANDIDATE

(PLEASE READ CAREFULLY BEFORE COMPLETING THE NOMINATION PAPER)

- 1. The Candidate must fill in the Nomination Paper personally.
- 2. The Candidate must mention the name of Office at Box "A" in PART I for which Nomination Papers are submitted.
- 3. The Nomination Paper must be filled in with BLUE ink.
- 4. The names in the box must match the names on the CNIC card of the Candidate, Proposer and Seconder.
- 5. All information required must be filled in. No question or information box can be left empty.
- 6. A clear photocopy of CNIC of the Candidate must be attached with the Nomination Paper.
- 7. A clear photocopies of CNIC of the Proposer and Seconder must be attached with the Nomination Paper.
- 8. Nomination Paper without the above copies of the CNIC of the Candidate, Proposer and Seconder shall not be entertained and received by the Election Commission at the time of submission.
- 9. The Nomination Paper must be submitted with the Election Commission in person by the candidate or the person duly authorized to submit the Nomination Paper. Nomination Paper submitted by any other person shall not be accepted.
- 10. The Candidate must NOT fill in Part III B and Part IV.
- 11. Part III A must be signed before the representative of the Election Commission.
- 12. The Candidate will be given the Receipt of Submission of Papers.\
- 13. Nomination Paper must be submitted and deposited with the Election Commission at the Head Quarters of the Pakistan Olympic Association at **80 P, Johar Town, Lahore.** In case of emergency please contact Secretary Election Commission for alternative arrangments.
- 14. The Scrutiny Committee Decision shall be communicated to the Candidate preferably by Email hence all candidates are encouraged to provide a valid Email address.
- 15. If a Candidate does not provide an Email address the Decision of the Scrutiny Committee will be informed by Telephone/SMS and the Original sent by courier to the address of the Candidate selected by the Candidate as the preferred address however, the Date of the Decision of the Scrutiny Committee shall be considered the Date on which the decision is issued.
- 16. No Candidate shall be permitted to alter or amend the contents of the Nomination Paper after it has been submitted and deposited with the Election Commission.
- 17. If any Candidate has an objection to the Representative of the Election Commission not receiving the Nomination Paper may contact the Secretary to the Election Commission and obtain an appointment and submit the Nomination Paper directly to the Secretary to the Election Commission.
